ACADEMIC INFORMATION

Academic Credits

Subjects offered at Taylor's University may carry an equivalence of 2, 3 or 4 credits.

Exchange students generally take 5 subjects per semester but may take up to 6, if there is no clash of teaching times. However 5 subjects may already be quite a substantial load for some students.

Exchange students must be enrolled for a minimum of 16 credits per semester throughout the Student Exchange Programme.

Please be advised that it is your responsibility to liaise with your home institution regarding the amount of credits that will be credited towards your studies as every institution has their own credit system.

Credit Transfer

Your transcripts will be sent to the exchange coordinator at your home institution.

Academic Calendar

- Taylor's University adopts a two-semester system. One semester commences in March and another commences in August.
- The semesters will start on the last Monday of March and August respectively.
- Each semester is approximately 18 weeks long. This comprises of 14 teaching weeks, 1 week semester break, 1 week study leave, and 2 weeks final examinations.
- Each semester usually has a mid-semester break and if classes fall on a public holiday, there will be no classes on that day.
- Depending on the programme you have enrolled for, classes may commence the same week as the Orientation or the week after. Thus it is important for you to attend every segment of the Orientation programme.

Add/Drop Subjects

You are free to add or drop your subjects within the first two weeks of the semester. Please consult the Academic Services of the respective School for the relevant forms to submit.

Deferment of Exchange Semester

All deferments are subject to the approval of the School to which you are applying for your exchange semester. Deferring may also mean having to resubmit your documents all over again and this may be treated as a fresh application. Approval for your first application may not necessarily guarantee approval a second time.

Withdrawing from the Student Exchange or Study Abroad Programme

You must inform us in writing of your intention to withdraw. Your exchange coordinator must also be notified.

APPLYING FOR THE STUDENT EXCHANGE & STUDY ABROAD PROGRAMME

Student Exchange Programme Entry Requirements

- Must be a currently enrolled undergraduate student of an institution that is recognized as an exchange partner of Taylor's University.

Study Abroad Programme Entry Requirements

- Must be a currently enrolled undergraduate student of a higher education institution abroad.

7. Nomination letter from your University stating that you have been selected for the Exchange Programme to Taylor's University for the stated semester
8. Student Curriculum Vitae (CV)
9. Payment of **RM541** via crossed cheque, bank draft, money order or telegraphic transfer (refer to page 15). The breakdown of payment is as follows:

8. A Medical Screening Report must be submitted with your application for Student Pass.
9. An International Certificate for Vaccination.

IMPORTANT NOTE:

Please note that depending on the modules you enroll for, you may be subject to uniform fees, equipment fees and other charges. You will be advised of these later when you have confirmed which modules you are enrolling for.

Application Terms and Conditions

- ▶ All applications are subject to the approval of the respective school of which you are applying for entry for your exchange semester.
- ▶ All applications are also subject to the issuance of the Visa Approval Letter (VAL) by the Immigration Department of Malaysia. If your Student Pass application is unsuccessful, you will not be granted entry into the Student Exchange Programme at Taylor's University.
- ▶ If you submit any additional documents at a time when it is too late for us to submit the Student Pass application on your behalf, we reserve the right at all times to decline your application. Thus it is important that you submit all the right documents on time.

- ▶ Your passport must have minimum one (1) year validity remaining upon arrival in Malaysia.

For example: if you are arriving in August 2016, your passport should expire no earlier than August 2017. If your passport is due to expire in July 2017, then you **MUST** renew the passport.

- ▶ If you have to renew your passport, please do so **BEFORE** submitting your documents. All forms and supporting documents submitted must bear the same passport number throughout. If you subsequently acquire a new passport **AFTER** submitting all the forms and documents, you will have to go through the hassle of resubmitting everything all over again using the new passport number. This is also applicable in the event of lost or damage of your passport.

- ▶ If your academic results are not in English, **please provide English translations along-with your academic results in the original language**. Applications without translated documents will not be processed.
- ▶ Please bring the original hard copies of all academic results / transcripts with you to Malaysia as you will need these when reporting to the International Office.

What are the purposes of all these detailed academic results/transcripts?

- I. Assessment by the school at Taylor's University
Your selection of modules will be based on the school's assessment of what you have studied at your home institution prior to commencing your exchange semester. If your transcript only lists the modules you have completed and already obtained grades for, please enclose a list of modules you are currently studying but have not obtained grades. This will assist the school in undertaking an accurate assessment of your level of familiarity and competence in the area of study at the point of entry into the Student Exchange Programme.
- II. Compliance with Ministry regulations
The Malaysian Ministry of Education requires that all students enrolled in a higher institution of study to meet all requirements in pursuing a degree programme. This also applies to exchange students who are not intending to graduate with a degree from the host institution. We are subject to regular audits by the Ministry and audits may extend to exchange students.

II. Evidence of English language proficiency

Please obtain a letter from your institution certifying that the language of instruction for all modules you have pursued and are currently pursuing is English.

If your modules have been delivered in a language other than English, please provide English language test results with a minimum score of TOEFL 550, IELTS 6.5 or equivalent.

III. Payment

FOR 1 SEMESTER EXCHANGE

- ▶ All exchange students, must make a payment of **RM541** (Ringgit Malaysia: Five Hundred and Forty One, including the Immigration charges)
- ▶ This charge includes the purchase of the ***Hospitalization & Surgical Insurance, and Visa Processing and Endorsement charges***. These are compulsory for all international students.
- ▶ **Goods and Services Tax (GST):**
Effective 1st April 2015, the Goods and Services Tax (GST) will be implemented in Malaysia at a rate of 6%.

FOR 2 SEMESTERS EXCHANGE

- ▶ All exchange students, must make a payment of **RM2028** (Ringgit Malaysia: Two Thousand and Twenty Eight, including the Immigration charges)
- ▶ This charge includes the purchase of the ***Hospitalization & Surgical Insurance, and iKad***. These are compulsory for all international students.
- ▶ **A short description about the iKad:**
Effective 1st July 2014 the International Students Card (iKad) was launched with an emphasis in security as a strategic effort to improve the management of foreign students in Malaysia. The iKad will be issued by the Immigration Department through their appointed agency; Education Malaysia Global Services (EMGS) for the purpose of new international students pass applications for entry and the renewal of pass application. The card will contain the particulars of student including passport number and information on the educational institution enrolled.
- ▶ **Goods and Services Tax (GST):**
Effective 1st April 2015, the Goods and Services Tax (GST) will be implemented in Malaysia at a rate of 6%. In order to comply with this directive, EMGS will impose the Government mandated charge of 6% on all student pass applications which is inclusive the payment of RM2028.

- ▶ **Please bring copies of your proof of payment with you to Malaysia.**

IMPORTANT NOTE:

All payments quoted are in Malaysian Ringgit. If the sum transferred falls short of the required sum upon conversion, you must make up the difference. Any surplus will be reflected as an excess payment.

If your application is rejected on the grounds of non-suitability for the student exchange programme or rejection of Student Pass, you may be eligible to a partial refund of the monies you have paid to Taylor's University. However please note that all refunds shall be in Ringgit Malaysia.

For example, if you have transferred a sum of USD 700 and upon conversion, this became RM 2170. The refund shall be made for the sum of RM2170, not USD700.

IV. Medical Screening Report (Health Examination Report) – *applicable for students that opt for 2 semesters of exchange*

Pre-arrival Medical Screening

Effective 1st July 2014, all international students intending to study in Malaysia must undergo Medical Screening at their home country prior to arrival in Malaysia. While undergoing this Medical Screening, you must bring along the **Health Examination Report** and the **International Certificate for Vaccination** (These two documents will be emailed to you by the coordinator in charge of TU) to the clinic and submit it to the doctor. The doctor must fill up both the Health Examination Report and the International Certificate for Vaccination. Upon completion of this procedure, you must retrieve the two documents and submit it via mail back to Taylor's University. Please ensure that the doctor has signed on both documents.

Post- Arrival Medical Screening

After arriving in Malaysia, you must undertake another Medical Screening within 7 (SEVEN) days. This Medical Screening will be conducted by an appointed medical/health clinic. The International Office at Taylor's University will guide you in the process of undertaking this procedure. If you are found to have met the health requirements, you will be granted the Student Pass. You will only be granted the Student Pass if you pass the Medical Screening. Certain types of diseases and conditions would disqualify you from obtaining a Student Pass. Please refer to the following tables below:

Programmes Organized for Exchange Students

There are programmes organized for exchange students in collaboration with the International Student Experience (ISE) Taylor's University.

Welcome Reception

1. The Welcome Reception is organized by International Student Services (ISS) and International Student Experience (ISE) for all international students.
2. It is usually held on the Friday before the Orientation programme commences. Kindly enquire at the International Office counter for the confirmed date.
3. You are strongly encouraged to attend this.

At the ISS briefing, you will be able to submit your registration for the Kuala Lumpur Familiarization Trip and get first hand information on the Medical Health Cover.

Orientation Programme

The date of your Orientation programme is stated in the Letter of Acceptance.

SERVICES FOR EXCHANGE STUDENTS

Airport Pick-up Service

- All airport pick-ups for international students (including exchange students) are managed by the International Office. The arrival form method has now been replaced by the **new pre-boarding system**.
- The link for this new pre-boarding system can be found here:

- All requests for airport pick-ups must be logged in at least five (5) calendar days before the date and time of arrival. Any requests made after this shall be automatically rejected and you shall have to find your own way to Taylor's University.
- Students are advised to schedule flights to **arrive** as follows:
 1. Arrive at the **earliest** 14 (FOURTEEN) days before the Orientation (Orientation date is stated in the Letter of Acceptance)

For example:

If the Orientation is to be held on 25th March, you may arrive as early as 11th March but not before this date.

2. At the following airports: (i) Kuala Lumpur International Airport 1 (KLIA 1); (ii) Kuala Lumpur International Airport 2 (KLIA 2); (iii) Subang Skypark Terminal
 3. On weekdays (Mondays, Tuesdays, Wednesdays, Thursdays, Fridays)
 4. Between 1000 hours and 1800 hours
 5. Avoid public holidays

Note that Taylor's University is located in the state of Selangor.
- Ensure you know which airport you will be arriving at (e.g. KLIA 1 and KLIA 2 are different airports) or else delays in pick-up may occur.
 - If you choose to arrive via other modes of transportation, you will need to arrange your own transportation to Taylor's University.
 - We advise exchange students from the same institution to make arrangements to travel together.
 - All airport pick-ups will transfer you from the airport to Taylor's University Lakeside Campus. You will be assisted with reporting to the International Office before you are brought to the Taylor's Hostel Management Office for accommodation check-ins.

Arranging for your own airport pick-up/transfer

- If you are arranging for your own pick-up/transfer to Taylor's University, there are taxi counters at the airport where you can arrange for a taxi to take you to our campus.

IMPORTANT NOTE:

We strongly discourage students from staying in the airport for extended periods of time to wait for the International Office staff to pick them up during the official pick-up times. It is far better for students to hire a taxi from the airport to the campus or a hotel (if the Taylor's Hostel Management Office is closed by the time you arrive on campus).

IMMIGRATION RULES AND REGULATIONS IN MALAYSIA

Regulations

Exchange students are classified as international students throughout their stay here with us. Exchange students are required to have a Student Pass for the entire duration of their study, whether it is for one or two semesters.

From **1st February 2013**, all international students intending to pursue a programme of study at any higher education institution in Malaysia shall have their Student Pass applications processed by an agency known as Education Malaysia Global Services (EMGS). **The Immigration Department of Malaysia is no longer processing Student Pass applications.** The introduction of a third party visa handling agency is expected to yield the benefit of a shorter processing time and less cumbersome regulations.

Immigration regulations are, at all times, subject to amendments as the authorities see fit. Taylor's University endeavours to keep international students updated of such changes at the time of application.

Student Pass Application

Obtaining the Student Pass is the responsibility of the Malaysian institution of higher education where the student will be studying at. Taylor's University will apply for Student Pass on behalf of all international students, including exchange students.

EMGS does not communicate directly with any international students.

Upon successful Student Pass application, EMGS will issue a Visa Approval Letter (VAL) to Taylor's University which in turn will then courier the original copy of this letter to the postal address you have provided in your application form.

Upon receiving the letter, you must immediately **apply for a single entry pass from the Malaysian Embassy in your country (if applicable)**. Once you have obtained the single entry pass, you may then start purchasing your flight ticket and prepare for your exchange / abroad programme here at Taylor's University.

The Significance of a Visa Approval Letter (VAL)

When a VAL has been issued, this means that your application for a Student Pass has been approved by EMGS and you now have permission to pursue a course at a Malaysian institution of higher education.

The VAL is valid only for six (6) months from the date of issuance. Please note that arrival should be at least a month prior to VAL expiry date. Once this has expired and if you have not submitted your passport for the endorsement of the Student Pass, you will have to resubmit your documents all over again for a new VAL.

Post-Arrival Things to do after arriving in Malaysia

1. Report to the International Office

Upon arrival at Taylor's University, you must report to the International Office.

What does reporting involve?

- a. Submission of your original passport
- b. Presentation of original academic transcripts and certificates
- c. Submission of Letter of Acceptance signed by yourself
- d. Presentation of Official receipts

Your passport is required for the endorsement to be placed in one of the pages contained within. The endorsement is a sticker issued by the Malaysian Immigration Department stating the terms and conditions of your Student Pass and its validity period. This process may take up to TWO (2) months so you will not have your passport in your possession during this time. If you are thinking of travelling during this time, please refrain from making any travel plans until you have your passport returned to you with the Student Pass Endorsement contained within.

Please note that endorsement of the Student Pass is a regulation set by the Immigration Department of Malaysia and all international students must comply with this.

2. Undergo a Medical Screening within three (3) working days of arrival
It is mandatory for you, within three (3) days of arriving in Malaysia, to undergo a Medical Screening which will be conducted by a medical/health clinic designated by EMGS.

Only when you have been certified to have a clean bill of health, will you be granted a Student Pass and a Student Pass endorsement sticker shall be placed in your passport. If you are found to be unfit for study, your Student Pass application will be rejected and you will be required to withdraw from the Student Exchange Programme and return to your country of origin.

The costs of undergoing the Medical Screening are included in the Education Malaysia Global Services (EMGS) charges. Thus you are not required to bear any additional expenses for this Medical Screening.

The Significance of a Student Pass Endorsement

The Student Pass Endorsement is the final step in completing the process for obtaining a Student Pass for international students. It confirms and seals your status as an international student in Malaysia.

If you have been issued a VAL but you have not submitted your passport for this endorsement or have not obtained this endorsement in your passport, complications may arise if you are subjected to random checks by the Immigration Department and found to not have completed this final stage.

Attendance

Regular attendance is compulsory. It is a regulation of the Malaysian Ministry of Higher Education that a student who is absent for three (3) consecutive days without valid reasons or prior permission has to be reported to the Police Department and the Immigration Department of Malaysia. Action may be taken which can result in the revoking of the Student Pass.

Travelling while studying

Travelling Within Malaysia

When traveling by plane within Malaysia, some officers at the airport will require production of a passport. A photocopy of your passport may not suffice. Thus please bear in mind that it is still necessary to have the original passport with you when travelling by plane even if it is domestic travel.

Sabah and Sarawak are part of Malaysia but different immigration regulations stipulate that foreigners must be able to produce a valid passport for the purposes of travel to and within these two states.

Travelling Outside Malaysia

With Malaysia's strategic location as a destination hub for many travellers, you are not restricted from travelling extensively during your time here as an exchange student. However it is your responsibility to ensure that you have the required visas when travelling to other countries and exit the country before the expiry of the visas. And again, please ensure that your passport already has the Student Pass Endorsement when travelling abroad during your exchange semester.

Note:

Please remember that for travelling purposes that requires the use of a passport, you must not make any travel plans until and unless you have your passport with you. There are times when you will not have your passport with you during your studies in Malaysia such as when you have handed over your passport to the International Office for the Student Pass endorsement and the Student Pass cancellation.

Working while Studying

International students are **prohibited** from working in Malaysia be it for full-time or part-time employment. If a student is found to have abused their Student Pass, they could be sentenced to imprisonment, a fine up to RM10, 000 or whipping.

Before Returning to Your Home Country

The All-important Checklist

Immigration Matters

Towards the end of your study, you are advised to submit your passport to the International Office at least TWO (2) weeks before the date of your departure. This is done for the purposes for submitting your passport to the Immigration Department of Malaysia for cancellation of your Student Pass.

Academic

Kindly submit a Clearance form to the respective Academic Services of the respective school for the programme you are enrolled for.

Accommodation

You would have paid a General Deposit prior to arrival in Taylor's University. Kindly approach the Taylor's Hostel Management Office to submit the refund form.

Outstanding Debts to Taylor's University

Kindly ensure that you do not have any debts owing prior to your departure. Any debts or outstanding amounts will inevitably result in the delay of receiving your transcripts and refunds of any monies owed to you.
